Savings Plus charges a quarterly administrative charge of \$6.00 per plan and a quarterly asset-based fee of 0.01% assessed against the first \$600,000 of your account balance, including active loan balances and Schwab Personal Choice Retirement Account (PCRA) balances, capped at \$60 per quarter per plan. These fees appear in the "Transaction Details" section of your quarterly statement and are withdrawn pro-rata from all funds.
